## **NOTICE OF PUBLIC MEETING**

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a regular public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas 77056, said address being a meeting place of the District.

## The meeting will be held on Monday, January 13, 2025, at 12:00 noon.

The Board shall consider and/or act on the following matters:

- 1. Receive comments from the public;
- 2. Review and approve the minutes of the December 9, 2024, Board meeting;
- 3. Discussion concerning Agreements with Lakes on Eldridge North and Villages at Lakepoint Homeowners Associations; and authorize any action necessary in connection therewith, including:
  - a) Status of Amendments to Agreements for Law Enforcement Services;
- 4. Authorize preparation and submission of District information to Texas Comptroller of Public Accounts as required by Section 403.0241, Texas Government Code, and Chapter 203, Texas Local Government Code, for inclusion in the Special Purpose District Public Information Database;
- 5. Status of continuing disclosure report due February 28, 2025;
- 6. Tax Assessor-Collector's Report, including authorizing the payment of invoices presented, approving refunds and moving of accounts to uncollectible roll;
- 7. Report and legal action taken by the District's delinquent tax collections attorney, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
- 8. Grant exemptions from taxation for 2025, and the adoption of a Resolution in connection therewith;
- 9. Adoption of Resolution Authorizing an Additional Penalty on Delinquent Personal Property Taxes and authorize delinquent tax attorney to collect delinquent personal property taxes beginning April 1, 2025, including the filing of lawsuits, as necessary;
- 10. Operation and Maintenance Report, including:
  - a) Monthly report;

- b) Compliance with permits and regulatory requirements, including review of any notice of violations, responses to notices and remedial action taken, self-reporting forms as and if required, and correspondence to and from regulatory agencies regarding same;
- c) Appeals of District charges;
- d) Authorize referral of delinquent accounts to a collection agency and write off of uncollectible accounts;
- e) Authorize the repair and maintenance of District facilities, and consider the status of ongoing repair and maintenance projects;
- f) Status of pressure monitoring tests;
- g) Status of purchase and installation of smart meters in the District,
- h) Consider proposal for pressure sensor installation on hydrants; and
- i) Status of UCMR-5 testing and the results of same, if applicable;
- 11. Bookkeeper's Report, including the review of financial and investment reports and authorizing the payment of invoices presented;
- 12. Adoption of amended operating budget for fiscal year ending August 31, 2025, and discussion regarding procedures to amend the District's budget;
- 13. Drainage and Detention Facilities Maintenance Report by Champions Hydro-Lawn, Inc., regarding maintenance of drainage and detention facilities, including:
  - a) Drainage Pipe Replacement at Calico Falls Lane and Ballina Canyon Lane; and
  - b) Status of paver replacement;

  - d) Status of construction of facilities to serve land within the District, including the approval of any pay estimates, change orders and/or acceptance of facilities for operation and maintenance purposes;
  - e) Review of Capital Repair and Maintenance Plan for the District's facilities;
  - f) Discuss proposal to repair CMP pipe outfalls from main LOEN lake to Turkey Creek, and authorize acceptance of TEC Form 1295 relative to same;

- g) Discuss proposal to update District's GIS Mapping System;
- 17. Issuance of utility commitments, and authorize acceptance of TEC Form 1295;
- 18. Discussion of renewal of District insurance coverages and authorize solicitation of proposals for same;
- 19. Attorney's Report, including:
  - a) Order Establishing Policy for Covered Applications and Prohibited Technology pursuant to Chapter 620, Texas Government Code; and
  - b) Ratification of the acknowledgement of receipt of the Municipal Securities Rulemaking Board Rule G-10 letter from Masterson Advisors LLC; and

Persons with disabilities who plan to attend this meeting and would like to request auxiliary aids or services are requested to contact the District's attorney at (713) 623-4531 at least three business days prior to the meeting so that appropriate arrangements can be made.

Pursuant to Sections 49.062(c) and (c-1) of the Texas Water Code, if fifty or more qualified electors reside in the District, five or more of said electors may make a written request to the Board to designate a meeting place and hold meetings within the District. The Board must grant such request unless no suitable meeting place exists inside the District, in which case a meeting place within ten miles of the boundary of the District may be designated. On the failure to designate a qualifying meeting place, five electors may petition the Texas Commission on Environmental Quality to designate a qualifying meeting place.
